Signs!

Have you seen all the signs at our street corners? Political signs, garage sale signs, lost pet signs, etc. This creates an eye sore that the district will eventually have to pick up. These types of signs are disposable to the owner and are placed and forgotten. They end up in our roads, open spaces, and storm water drainage ditches, which makes our community look trashy. The plastic signs on weak metal frame can blow away within a day or two. The wooden staked signs have nails that go through the stake and become a hazard or safety concern. Signs are often taped to street and traffic signs. DO NOT place anything on street or traffic signs as this is illegal and all of the tape can never truly be removed.

If any signs are on District property, regardless of content, we do the following:

- 1. Any disposable sign placed on District property without a <u>resident's address</u> will immediately be removed. If the sign is made of sturdy material that is not intended to be disposed of, it will be left alone. Ex: Grace Community Church or some house for sale signs.
- 2. If the resident's address is on the sign it will be left alone, but the resident will be responsible for picking up the sign.
- 3. Any sign taped to a street or traffic pole will be removed immediately even if there is an address on it. Remember this is illegal.

Bald Eagle Cardboard Tube Craft

You will need:

- 4-inch cardboard tube
- Construction paper: brown, white and yellow
- 2 googly eyes
- 2 brown feathers
- Tools: tape, white craft glue, scissors



- Step 1: Cover the cardboard tube with brown construction paper
- Step 2: Cut a strip of white paper (about 1 ½ ") and attach to the top of the cardboard tube
- Step 3: Use tape to make sure all the seams are secure. Cut out a beak and feet from yellow paper and attach to the face and bottom of the tube.
- Step 4: Glue on googly eyes and feathers
- Step 5: For fun, you can add a paper bow tie or make an American flag from paper and a toothpick to embellish your eagle
